Company overview

Founded in 1918, Bretts was originally a sawmilling business with mills located across southern Queensland. Over the years and as wood fibre resource availability diminished, the business has expanded and diversified into manufacturing and selling a wide range of building materials.

Bretts is 100% owned by third generation descendants of James Brett and is located across 11 locations throughout Queensland. Combined turnover in 2023/24 was in excess of \$136 million with staff of more than 300 full-time employees. Bretts are a 100% vertically integrated building supply business, sourcing input materials direct from manufacturers, and value adding to produce house frames and trusses, aluminium windows and doors and timber joinery.
